WCTE Board Meeting Thursday, October 15, 2015, 5:45p UW-Milwaukee Continuing Educ Conference Center, 161 Wisconsin Ave. #6000, Milwaukee WI 53203

Meeting called to order at 5:53 P.M.

- 1. Welcome and Introductions: Meeting began by introductions: John Pruitt, Martha Handrick, Denise Meyer, Tom Scott, Shelly Moore Krajacic, Jennifer Kieren, Marianne Potter, Kara Sommerfelt, Marci Glaus, Kathy Nelson, Linda Barrington, Lynn Aprill, Wendy Kropid, Lynn Frick, Marti Matyska, Jacalyn Mabon, and Kelly Seefeldt
- 2. Approval of Agenda. Barrington/Aprill approved
- 3. Approval of July 2015 board meeting minutes. Meyer/Handrick approved
- 4. Treasurer's Report, including Membership (Tom Scott) we have not yet gotten payments from Reg Online, so not a clear picture of where we are at at this time. It appears that we have total revenues for this convention between \$15,100 and \$15,800. Expenses appear to be a little under \$5,000. Jeff's expenses will run about \$6,000. Thereby a total of \$11,000 in expenses with a profit of upwards of \$4,000. As of September 22, checking at \$9400, \$15,000 in money market account, \$14,000 in cd, \$1800 in savings. Tom thinks we are in pretty good shape at this point. There will be exact figures at the later board meeting after January 31.

Registrations are coming in late, but Reg Online does appear to be convenient for people who wish to pay by credit card.

Membership. Current members or very recent expirations we have 205 members. It is higher than it has been the last couple of years.

Challenge with getting into the Milwaukee Public Schools. Some brainstorming about next year's conference and possible presenters and challenges to the conference. Discussion about having a Saturday convention.

- 5. DPI Report (Marci Glaus) Marci passed out a document with her report. Wisconsin Writes has launched. Marci also updated the board on state assessment, the new licensure laws and requirements, a few other updates. She is working on an evaluation/survey of ELA educators in Wisconsin. She shared the survey with the board which was then discussed.
- 6. Officer Reports
- a. President (John Pruitt)

- The bylaws (ugh!), inc. writing in MASA Lynn went through proposed changes to the by-laws. With some discussion, they seem was no objection to the proposed changes.
- ii. Affiliate plans for Literacy Education Advocacy Day/Month, March 2016 John asked what our plans are for this. Various ideas were bantered about. Possibility of doing a "book club" with a Kelly Gallagher book that ties into next year's conference.
- iii. Message from Linda Barrington regarding the Student Freedom of Expression Act: "This past April the North Dakota legislature (heavily Republican) unanimously passed the New Voices Act, giving freedom of expression protection to student journalists in high schools and colleges. Wisconsin college and high school advisers have formed a coalition to propose similar legislation in Madison. In our early stages, we are drafting the bill and looking for a broad base of support within the state and beyond. We would like the endorsement of WCTE. Do you know how to go about doing this? Should I present a statement of endorsement to the board? Or should I just ask for endorsement and let someone else on the board prepare the statement? How should I proceed?"

Linda presented on this concept. Idea was that the board needs to read the actual bill before agreeing on endorsement.

iv. Collaboration with Greater Madison Writing Project on High School/College symposium referenced in July 2015 minutes. Message from Mark Dziedzic: "We just met with the [UW Madison] English department on Friday [October 9] for the first time. It looks like we are going to have two days - tentatively Friday, January 29th and either the last Friday in February or first Friday in March. The first day would be similar to last year, with panel discussions followed by table group discussions. The second day would have people going to either half day or full day workshops on a particular focus area - argumentative, persuasive, digital literacy, etc. I'd love for you to put it out to the group, but it is just starting to come together. I told everyone at the meeting that I need to have firm plans in hand by November 13th so I can present it to the area school district directors of instruction meeting.

(Would like to see this collaboration with the state's other NWP sites).

b. First Vice President (Denise Meyer) - Marti would like people to be sectional chairs to encourage evaluations. Also, Linda would like folks to collect write-ups from the presentations that people thought were REALLY good for the WCTE Update. Also, take photos with your phones. - e. Standing Committee on Diversity (Justina Plemon) Submitted by Justina via email: "Proposed Diversity Chair Position Description. Standing Committee on Diversity Chair: The Standing Committee on Diversity chair is an appointed, unpaid position for a term of three years. The Standing Committee on Diversity chair is charged to promote and support ongoing dialogues about diversity and difference in all aspects of teaching. To carry out this general charge, the Standing Committee on Diversity chair shall form a committee which is particularly charged: to gather data about underrepresentation of people of color and other minorities in our membership including surveys of the membership that better identify the organization's level of diversity, including members' rank and institutional affiliation; to poll the membership regarding the effectiveness of WCTE in meeting the needs of our many different constituents, as defined by race, ethnicity, gender, disabilities, and sexual orientation; to develop resources that will support our members in teaching for diverse student bodies, such as a conference demonstrating culturally responsive practices as addressed in the Rtl model, and practical resources about teaching writing in diversity-rich environments; and to propose position statements on diversity in the profession and teaching for consideration by NCTE. The Standing Committee on Diversity chair shall maintain affiliation with other NCTE/CCCC committees where possible to improve efficiency, including the Committee on Diversity, the Committee on Disability Issues and the Committee on LGBT/Q Issues."
